# ORDINANCE 03 -

#### AN ORDINANCE IN REFERENCE TO VILLAGE EMPLOYMENT

WHEREAS, the Street Department posted the position of Buildings and Grounds Technician on the department bulletin board and advertised the position in the Chatham Clarion; and

WHEREAS, the Director of Public Works and the Street Department Lead Worker conducted interviews of five potential candidates and prepared recommendations for the Administrative Committee.

WHEREAS, on January 21, 2003 recommendations were presented to the Administration Committee who is recommending the appointment of Howard Clayton and Harry Hunt as the preferred candidates.

BE IT ORDAINED, by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

SECTION 1: Howard Clayton and Harry Hunt shall be employed in the Street Department as Maintainers on a full time basis paid an hourly wage of \$11.663. The distribution shall be 90% from the General Fund and 10% from the Water Fund. Per the current contract employees shall serve an 120 day probationary period ending June 1, 2003, at which time the hourly wage shall be \$12.392.

SECTION 2: This Ordinance shall be in full force and effect upon passage and approval.
