## AN ORDINANCE APPROVING THE FINAL PLAT OF SUBDIVISION OF OAKBROOK ESTATES PLAT 12

SECTION 1: The final plat of subdivision of Oakbrook Estates Plat 12 is hereby approved. The President is authorized and directed to sign said Plat 12 on behalf of the Village.

SECTION 2: Security in the amount of \$30,000 for construction of the public improvements in Oakbrook Estates Plat 12 is sufficient and is hereby approved. National City Bank has approved Letter of Credit No. SC008888 is approved as surety therefor.

SECTION 3: This Ordinance is effective immediately.
