Ladies and Gentlemen:

Thank you for the opportunity to act as bond counsel for the proposed debt certificates by the Village of Chatham to be issued to United Community Bank.

As bond counsel, we would perform all usual and customary services provided by bond counsel in connection with the issuance of the debt, including the preparation of the debt ordinance, closing certificates, opinions and other related financing documents. Assuming no material changes in the financing occur during the course of our work, our fee would be \$5,000 plus any out-of-pocket expenses such as photocopying and paid at closing.

In the event that during the course of representation we are requested to perform additional legal services not customarily performed as bond counsel or because the financing materially changes, those services would be charged at an hourly rate ranging from \$65 to \$150 per hour depending upon the nature of the service and the professional performing the services. We understand that the issuance of the debt is tentatively scheduled for July 28, 2003. In the event the Village elects not to proceed with the borrowing or postpones the closing beyond September 1, 2003, we would submit our itemized statement and be paid at that time for services rendered at the rate of \$150 per hour.
