Ordinance No. 03- 49

AN ORDINANCE AMENDING THE VILLAGE OF CHATHAM CODE OF ORDINANCES BY ADDING PROVISIONS RELATING TO BANQUET HALL LIQUOR LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMOUN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The following definition is hereby added to Section 111.01 of the Village of Chatham Code of Ordinances:

BANQUET HALL: A business organized in such a way that it provides a place, available for rental by members of the general public. The building housing the business shall be designed to accommodate a minimum of 50 persons safely. Such a business is typified by wedding celebrations, parties, business meetings, or dances by private clubs or individuals. In this type of business, the lessor or licensee is paid a fee by the lessee for use of the hall and or providing alcoholic liquor.

SECTION 2: Section 111.17 of the Code of Ordinances of the Village of Chatham, is amended by the addition of subsection (A-1), as follows:

(A-1) A Class B "Banquet Hall" license shall authorize the service or sale of alcoholic liquor by retail, to be sold and served by the drink or pitcher only, although beer may be sold by the keg so long as it is served by the drink or by pitcher, for consumption on the premises only, in the course of banquet hall business. In the course of this business, the licensee is responsible for control of patrons in the business premises, and at no time may patrons be allowed to act as bartenders or otherwise dispense liquor. At all times that the premises are used for the sale of alcoholic liquor, the licensee or a manager

acting for the licensee must be on the premises. The annual fee for such license shall be \$800.00 payable in two installments, namely \$400.00 on December 31 of each year, and \$400.00 on June 30 of each year.

SECTION 3: Section 111.17(I) of the Village of Chatham Code of Ordinances is amended to state as follows:

- (I) The number of licenses issued by the Village shall be as follows:
 - (1) There may be one Class B license.
 - (2) There may be four Class C licenses;
 - (3) There may be one Class G license;
 - (4) There may be one Class N license;
 - (5) There may be two Class P licenses;
 - (6) There may be one Class R-1 license;
 - (7) There may be no Class R-2 licenses;
 - (8) There may be one Class SE license outstanding at any time;
 - (9) There may be three Class T licenses.

SECTION 4: Section 111.22 of the Code of Ordinances of the Village of Chatham is amended by the renumbering of subsection (A)(4) to (A)(5); by the renumbering of subsection (A)(5) to (A)(6), and by the addition of a new subsection (A)(4), to state as follows:

- (4) It shall be unlawful for the holder of a Class "B" license to sell or offer for sale at retail any alcoholic liquor in the village during the following hours:

- (a) Monday through Thursday: 12:00 midnight to 8:00 a.m. and after 11 p.m.
- (b) Friday: 12:00 midnight to 8:00 a.m.
- (c) Saturday: 1:00 a.m. to 8:00 a.m.
- (d) Sunday: 1:00 a.m to 12:00 noon and after 10:00 p.m.

SECTION 5: The Class R-2 licensee whose license was eliminated by this Ordinance shall be eligible to receive the Class B license created by this Ordinance, with credit for any license fees paid pursuant to the R-2 license.

SECTION 6: This Ordinance is effective upon its passage and approval. The Clerk shall see to its inclusion in the next published update of the Village Code of Ordinances, and shall mail a copy to every liquor licensee in the Village.


