## CONSULTING AGREEMENT

This agreement is between Timothy S. McAnarney ("Consultant") and the Village of Chatham, an Illinois municipal corporation ("Village").

1. During the term of this agreement, Consultant shall assist Village in its efforts to create economic development, as requested from time to time by, and in consultation with, the Village President or other officers and employees of the Village as specified by the Village President. Consultant shall provide advice and assistance regarding the Village's dealings with federal, state and local governmental agencies with respect to economic development, and will assist with the procurement of governmental grants and low interest loans as appropriate. Consultant shall provide advice and assistance regarding the Village's dealings with developers, retailers and other potential businesses with respect to economic development.

2. For his services, Consultant shall be paid the sum of \$2,000 per month on or about the first day of every month during the term of this agreement.

3. Consultant is an independent contractor for all purposes relating to wages, hours, social security, and other terms and conditions of employment. The Village shall have no control over the number of hours worked by Consultant or Consultant's methods of doing business. Consultant shall not hold himself out to the public as an employee of the Village, and shall have no authority to contract on behalf of the Village or otherwise to bind the Village.

4. The term of this agreement shall be from November 1, 2003 through October 31, 2004. This agreement may be terminated by either party without cause upon


30 days written notice. This agreement may be terminated by the Village for cause and without prior notice in the event of material noncompliance by Consultant with its terms. The agreement may be terminated by Contractor for cause without prior notice in the event of the Village's failure to pay.




