

**RESOLUTION NO. 36-24**

**A RESOLUTION APPROVING THE PURCHASE OF THREE POLICE VEHICLES  
FROM VICTORY LANE**

**WHEREAS**, the Village of Chatham (“Village”) is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

**WHEREAS**, the Village requested bids for a three new police vehicles; and

**WHEREAS**, the Village received one bid from Victory Lane for two 2024 Dodge Durango police vehicles at a price of \$43,746.00 each for a total of \$87,492.00, and one bid from Victory Lane for one 2024 Dodge Special Service Vehicle (SSV) at a price of \$44,563.00 and,

**WHEREAS**, the Village intends to accept the bids from Victory Lane for the purchase of two 2024 Dodge Durangos and one 2024 Dodge SSV as further described in the bid information attached hereto as **Exhibit A**; and,

**WHEREAS**, the Village Police Department has budgeted sufficient funds for the purchase of these vehicles; and,

**WHEREAS**, the Board of Trustees of the Village believe it is in the best interest of the Village to accept the quote from Victory Lane as attached hereto.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

**Section 2.** Acceptance of Quote. The Village hereby approves the quotes for the purchase from Victory Lane of two 2024 Dodge Durango police vehicles in the amount of \$43,746.00 each and one 2024 Dodge SSV in the amount of \$44,563.00 for a total of \$132,055.00 as further described in the attached **Exhibit A**. Any and all quotes and parts thereof not explicitly



approved by this Ordinance are hereby rejected. The Village authorizes the Village Manager and/or Village President, or designee of either, to execute any documents necessary to complete the purchases contemplated therein.

**Section 3.** Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this Resolution and the application thereof to the greatest extent permitted by law.


